

NOTICE OF ELECTION AND NOTICE TO SUBMIT ARGUMENTS

NOTICE IS HEREBY GIVEN that an all-mail Special Tax Election will be held on August 25, 2020 for San Andreas Fire Protection District, Lynn Park Acres Community Services District and West Point Fire Protection District for the purpose of voting on the following measures:

Measure A

To sustain the San Andreas Fire District staffing of its station and the equipment, facilities, training program, insurance and other systems necessary to protect lives, homes and businesses, shall the measure adding a special annual tax of \$300 per improved property and \$150 per unimproved property, without expiration, except for exemptions as set forth in resolution 2020-04-01, generating approximately \$560,000 in revenue and increasing the District's appropriations limit equal to revenue received, be adopted?

Measure B

To maintain Lynn Park Acres Community Service District roads shall a new special tax, replacing the existing one of \$100 per improved lot and \$75 per unimproved lot, be adopted without expiration, at \$200 per improved lot and \$150 per unimproved lot? This increase would generate \$15,050 annually and would be collected semi-annually via property tax payments.

Measure C

To maintain a rapid local emergency medical and fire response solely within the West Point Fire Protection District, and continue current staffing of firefighters and equipment ready for emergencies, shall a special property tax of an additional \$180.00 per year per parcel, raising approximately \$350,000.00 annually, be adopted by the District, with a discretionary annual adjustment equal to the California Per-Capita Personal Income, but no greater than 3%, with all funds staying in our community?

NOTICE IS FURTHER GIVEN that arguments for or against the above measures will be accepted in the office of the County Clerk, Election Division, at 891 Mountain Ranch Road, San Andreas, CA 95249. Arguments shall not exceed 300 words in length and shall be titled either "Argument In Favor Of Measure ____" or "Argument Against Measure ____." Arguments must be filed no later than 5:00 p.m. on, May 22, 2020.

A ballot argument shall not be accepted unless accompanied by the name or names of the person or persons submitting it or, if submitted on behalf of an organization, the name of the organization and the name of at least one of its principal officers. No more than five signatures shall appear with any argument. All arguments must also be accompanied by a statement that the argument is true and correct to the best of his/her/their knowledge and belief.

If more than one argument for and one argument against the measure is received, the selection will be made pursuant to the provisions of the Elections Code 9166.

NOTICE IS FURTHER GIVEN that if an argument in favor of and an argument against the measure is submitted, copies will be mailed to the respective authors. The authors may prepare and submit a rebuttal argument not to exceed 250 words in length. Rebuttal arguments must also be accompanied by a statement that the argument is true and correct to the best of his/her/their knowledge and belief. The deadline for filing a rebuttal argument will be 5:00 p.m. on June 1, 2020.
